1.ELIGIBILITY FOR ENTRY

The awards are open to all Musicians, Producers, Editors, Production Video Companies, Fashion Stylists, Makeup artists, Concepts video creatives, choreographers who are citizens or legal residents

of the Republic of South Africa or someone who has granted a permanent resident status in South Africa for a minimum period of six (6) months prior to the date of enty.

The category for best International African music video is open to all recording artist, producers, directors, editors companies as mentioned above. We accommodate musical artists then from African continet (outside of South African Borders).

Only the work that has been released in the past 60 months.

All music videos submiteed for the 3rd Annual Eminent Video Music awards in the category must be quality resolution videos (resolution must be higher than 360p).

No entry will be considered if the entrant has failed to settle any outstanding fees owing to the Eminent Video **Music Awards.**

International collaboration and productions are urged and encouraged to enter, provided that any collboration is predominantly by South African Artist(s), Producer(s), Director(s) and such artist(s) or producer(s) or Director(s) have star or equal billing on the realease.

Affter the closing date for entries a process will be implemented to ensure that all entries are placed in the most correct or most appropriate category.

General Rules

EVMA house judges accepts no responisbilty whatsoever for any problems resulting from incorrect entries.

EVMA judges shall not be reqired to provide reasons and proof of any decisions taken in respect of the competition.

The judges decision is FINAL in relation to any award and no correspondence will be entered to the judge's decision.

Should the application be successful, the nominee may be required to record any audio-visual message that could be used for broadcast or any other publicly purposes and a copy therof should be submitted via email or delivered to EVMA offices by no leter than 30 days before the main ceremony.
